



Updated 9/1/20

The 2020 - 2021 season begins on August 1, 2020 and ends July 31, 2021.

Tuition

- Due to Covid, tuition this year will be month to month for all swimmers. The annual tuition amount will still be the same but it will be spread over 9 months.
- The first tuition payment will begin on October 1, 2020 and continue on the first of each following month. The final tuition payment is on June 1, 2021.
- Swimmers are automatically enrolled and billed for the following month.
- The monthly tuition payment is non refundable. If we're required to shutdown and the shutdown continues into the following month, tuition will not be charged for the new month. Tuition will not be charged until we return and it will be prorated for the month.
- Families may permanently or temporarily withdraw from the team with no financial penalty. Email Coach Brandon at least 3 days before the 1st of the month.

Fees

- The annual non refundable non-team-specific fees will be billed on 9/7/20.
- \$80 per swimmer USA Swimming insurance and team registration fee. This is a required fee for swimmers and teams to be a part of USA Swimming.
- \$100 per swimmer pool rental fee. Our contract with Hauppauge requires us to pay rent during times of non use. This includes government mandated shutdowns.
- All credit card processing fees will be passed on and added to invoices.

Discounts

- 5% for the 2nd swimmer.
- 10% for subsequent swimmers.

Volunteer Fee

Under normal circumstances these would be the volunteer fees. \$50 for 1 session at our October meet and \$150 for 3 sessions at our December meet. Sessions must be worked by an adult 18 years of age or older.

Meet Fees

If applicable this year due to Covid restrictions. Meet fees are set by the host. We bill our families at the beginning of the following month and pay the meet host directly. September meet fees are paid on October 1 as an example.

Obligation To Pay Meet Fees

Once our meet entry is submitted to the meet host and accepted we are bound by the rules of the information packet. One of the rules within the information packet is that meet fees must be paid before we attend the meet. Since we already paid for the meet fees based on commitment, you're obligated to pay the meet fees even if your swimmer doesn't show up.

Non Home Meet Volunteer Requirements

Some swim meets that we attend require us and other attending teams to volunteer. Failure to comply with these rules will result in our swimmers being removed from the meet. These volunteer requirements are separate from our home meets. They don't count towards our home meet volunteer fee.

Payment

All fees are paid by credit card through your account on our website. A credit card must be entered before a swimmer can participate on the team. All accounts must be current in order to participate in practices and meets. \$25 late fees are automatically charged by Team Unify. Team Unify is the name of the billing system we use. The late fee is charged after 7 days of non payment. Contact Coach Brandon with any billing questions.

Payment Obligation

It is the Club's policy that payment of the USA Swimming insurance fee is your acknowledgement that you have received clearance from your swimmer's primary care physician that the swimmer is cleared to participate in all club practices and events, and you agree to be bound by all policies of the Hauppauge Athletic Association (Hauppauge Swim Club, Hauppauge Swimming), as published on this website or elsewhere, without limitation:

1. Code of Conduct – specifies what is expected of swimmers and their families.
2. Photo Release – gives the Club permission to use your child's photo.
- 3 - Obligation to Pay - Payment for the month is non refundable.
